FIRST

Complete an application for admissions in the **Enrollment Services office** of the SJC North Campus in the Spencer Administration Building, or you may go online to www.sjcd.edu to complete an application for admissions online.

SECOND

Submit official transcripts to the Enrollment Services office.

High School ...students must show High School graduation or successful completion of all sections of the GED. Foreign students must submit an evaluation of their High School and/or College instruction from their home land. The evaluation must be evaluated by a San Jacinto College District approved evaluation site. You may obtain a list of approved evaluation sites from the Enrollment Services office.

College Transcripts...students must submit all previous and current official college transcripts to the Enrollment Services office. You may at that time request a copy of the transcripts that you are submitting.

***You will need a copy for reviewing in the Vocational Nursing office.**



THIRD

Contact an Advisor in the Counseling Department regarding any admissions/placement testing that may be needed. If you have already completed your college placement test you must have an Advisor review your scores to verify skill levels.

Skills levels ...must be a minimum of “7” in reading, “7” in math, and “7” in writing. Remediation is recommended for any area, (reading, math, or writing), if skills levels are below required levels.

During any assigned Vocational Nursing application session, students must bring the following documentation ...

*** High School diploma or transcript, GED or High School transcript evaluation**

*** All previous and current college transcripts**

All college credits must meet an overall grade point average, (GPA) of 2.25.

All Students must be in good standing.

***Skills Level evaluation received from an Advisor in the Counseling office.**

YOU MUST MEET REQUIREMENTS BEFORE YOU ARE ELIGIBLE TO FILL OUT AN APPLICATION.

Applications may be completed in the VNSG office in the Wheeler Building (B2029).

NOTE: Effective January 1, 1996, a person who has been convicted of a felony....may be disqualified from obtaining licensure as a Licensed Vocational Nurse. If you have any questions regarding past incidents, please call the Texas Board of Nursing at (512) 305-8100. **NOTE:** Since August 2004, a criminal background check and/or drug screening has been conducted by a designated investigative agency at the expense of the student. Effective January 2008 this background check must be completed before registering for classes and only those applicants with a clear background will be eligible to register.

SELECTION PROCESS:

You must meet eligibility and fill out all appropriate paperwork in the VNSG office to be considered prior to the application deadline.



The selection process will then be based on pre-entrance nursing exams, skills levels, and cumulative GPA. The selection of students for the upcoming semester will be announced in a letter of "acceptance" to the applicant. A letter of "regret" will be sent to those not selected.

All VNSG students will be required to pay by telephone/web registration deadline date or be dropped by the system. Open slots in enrollment will not be held. In order to assure your registration into the semester, payment must be made by telephone/web deadline payment date. A *maximum* of 70 students (depending on clinical availability each semester), will be enrolled for Level I. Enrollment may be limited to less than 70.



Physicals, immunizations, and CPR cards are due on the first day of class.

* **NOTE: Effective January 1, 2005, all eligible applicants must have completed the Hepatitis B Series.** Therefore, prior to entry into the program this requirement must be met [Department of State Health Services (DSHS)].

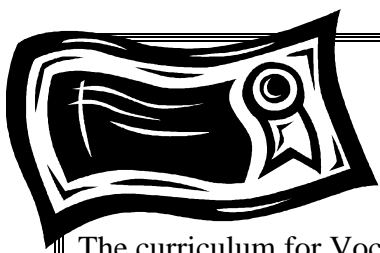

Examination Fees:

The Vocational Nursing program is now requiring a HESI entrance exam and a EI test, in addition to the Nelson Denny. The cost of the HESI entrance exam is \$30. The test will be administered to all applicants accepted into the program on 5/15/09 at 9:00 a.m. It is mandatory that the tests be completed on that date. Failure to attend will forfeit your opportunity to register for Vocational Nursing classes. Money Orders should be made payable to HESI.

Parking Fees:

*Parking fees are required at certain clinical facilities. The charges range from \$2.00 to \$15.00 per day. A CPR card (**American Red Cross - Healthcare Provider**) is required before classes begin. It is the student's responsibility to secure CPR training.
